Safety First: a harm-reduction based, drug intervention curriculum

High School Program

- 13 session program
- Safety First is meant for high school students- the purpose of the curriculums is to encourage youth to abstain from use, but the curriculum also includes a clear harm-reduction message for youth who are experimenting or using.

FUNDING OPPORTUNITY

You can apply for up to \$5000 per school/setting to either sustain current programming or implement new programming.

Funding can support:

- Purchase of student materials
- Purchase of curriculum sets for facilitators
- Fees for facilitator training
- Purchase of supplemental programming (for Botvin Lifeksills)
- Staff time to implement programming
- Purchase of other materials needed to implement programming

FUNDING REQUIREMENTS

- Complete online application [HERE](#) by February 20, 2025
 - If you are applying on behalf of more than one agency/school, fill out a separate application for each
 - Application will ask you to select which Northwoods Coalition member coalition you are associated with- if you do not know which coalition serves your county, please contact our team
- This funding is designed as a reimbursal program
 - If awarded, you will be required to contract with Marshfield Clinic Health System up front and then invoice upon ordering/training completion (invoice template will be provided)
 - Invoices are due Sept 1, 2025
 - All purchases & trainings must be completed by this date
- Awardees must agree to track & provide the following information to the coalition listed on their application:
 - *Number of school-aged children received programming*
 - *Number of people trained to provide programming*
